Purpose of this guide

The main purpose of this document is to ensure you are given adequate information about the financial services being offered. It contains information about the services Alteris Lifestyle Care can offer you; how any associates are paid; any potential conflict of interest and the internal and external dispute resolution procedures and how you can access them.

This guide should help you decide whether to use any of the financial services Alteris Lifestyle Care can provide. You will be given a Statement of Advice (SOA) whenever personal advice as defined by s766B of the Corporations Act is provided to you. Your SOA will contain any personal advice we provide to you, the basis on which it is given and information about fees and associations that may have influenced the provision of the advice. If further advice is furnished, a Record of Advice (ROA) may be provided to you instead of a SOA. You have the right to request a copy of the ROA (if you have not previously received a copy) within seven years of that further advice being given.

If Alteris Lifestyle Care recommends a Financial Product, you will also be given information about the Financial Product via the Product Disclosure Statement (PDS). The PDS will assist you in making an informed decision about the Financial Product. Alteris Financial Group Pty Ltd (Alteris Financial Group), the Licensee responsible for the advice Alteris Lifestyle Care provides holds Professional Indemnity Insurance cover for the activities conducted under its Australian Financial Services Licence. The insurance will cover work completed by advisers and employees of Alteris Lifestyle Care even if they have since left the company. We believe that the Professional Indemnity Insurance cover satisfies the requirements of s912B of the Corporations Act.

Throughout this Financial Services Guide (FSG), Alteris Financial Group Pty Ltd is referred to as 'Alteris Financial Group' and Alteris Lifestyle Care Sydney Pty Ltd and Alteris Lifestyle Care Brisbane Pty Ltd as 'Alteris Lifestyle Care'.

<p>What kinds of financial products is Alteris Lifestyle Care unable to provide?</p>	<p>Alteris Lifestyle and Care only provides financial advice in relation to supporting your retirement living and aged care needs and goals. However, Alteris Financial Group can provide advice on a range of additional wealth management and accounting services. If required, a referral can be arranged to see one of our financial advisers at Alteris Financial Group or accountants at Alteris Accounting.</p>
<p>What information should I provide to receive personalised advice?</p>	<p>Alteris Lifestyle and Care will complete a client questionnaire with you, which will record your personal objectives, lifestyle goals, details of your current financial situation and any relevant information, so that you receive the most appropriate advice.</p> <p>You have the right to withhold private information, but this may compromise the effectiveness of the information and options presented in Discussion Papers and the recommendations in your Statement of Advice. You should read the warnings contained in the client questionnaire and Statement of Advice carefully before making any decision relating to a financial strategy or product.</p>
<p>What information do you maintain in my file?</p>	<p>Alteris Lifestyle Care maintains a record of your personal details, objectives, and financial situation. Alteris Lifestyle Care also maintains records of any recommendations provided to you. If you wish to examine your file, it is available upon request.</p>

<p>How will Alteris Lifestyle Care and its financial advisers be paid for the services provided?</p>	<p>All financial advisers receive a salary, along with the potential for discretionary bonuses and Performance Rights Entitlements issued by Alteris Financial Services, a wholly owned subsidiary of Alteris Financial Group. They do not receive commissions and are not entitled to any additional benefits.</p>
<p>How to provide Alteris Lifestyle Care with instructions?</p>	<p>Your financial adviser may accept your instructions in person, by phone, letter, email or fax. In some instances, your adviser can only accept written instructions from you and they will let you know when this occurs.</p>
<p>Relationships and Associations</p>	<p>Alteris Lifestyle Care is a wholly owned subsidiary of Alteris Financial Group and will be entitled to any profits generated.</p>
<p>Will anyone be paid for referring me?</p>	<p>Alteris Lifestyle Care does not have any formal referral arrangements in place that involve the payment of a fee or commission to a third party. Any referrals made are done so on a professional basis.</p>
<p>How we provide our advice services to clients.</p>	<p>To support the efficient delivery of our services, we may utilise both employees and third-party service providers, including administrative and paraplanning support teams located in Australia and overseas (including New Zealand, Vietnam and the Philippines).</p> <p>These providers assist with back-office administration support and document preparation functions. They do not provide personal financial advice directly to clients and are not authorised representatives.</p> <p>Where personal information is accessed overseas, they do so by connecting to our systems and we implement security controls and oversight measures consistent with our Privacy Policy. We remain fully responsible for the financial services provided to you and for ensuring appropriate supervision of our outsourced arrangements.</p>
<p>What should I do if I have a complaint?</p>	<p>If you have any complaints about the services provided to you or about personal information held you should take the following steps:</p> <ol style="list-style-type: none"> 1. Contact your financial adviser and tell them about your complaint. 2. If your complaint is not satisfactorily resolved, contact Alteris Financial Group on +612 8078 0888 or put your complaint in writing to the Complaints Officer and send to info@alteris.com.au or GPO Box 7118, Sydney NSW 2001. You will be advised within 30 days of our decision. If the matter is complex and a longer period is required, you will be informed. 3. Alteris Financial Group is a member of the Australian Financial Complaints Authority (AFCA) membership number 25830. If you do not get a satisfactory outcome, you may escalate your complaint by contacting AFCA on 1800 931 678, by post at GPO Box 3, Melbourne, Victoria 3001 or visit their website www.afca.org.au.
